Bringing a pet into Eden Gardens must be for the benefit of the residents.

The following guidelines have been created for the well-being of this pet and the convenience and consideration of our staff, families, residents, and volunteers.

For this pet's safety and the safety of our residents and staff, please follow these Guidelines:

- This pet must be on a leash and/or under your supervision.
- This pet must be fully trained and appropriately restrained when other people are nearby.
- This pet must not be left unattended.
- You are responsible for cleaning up after this pet while it is on the property of Eden Gardens.
- Any disturbances such as barking must be curtailed to ensure others are not disturbed.
- Owners are responsible for all property damages and/or personal injuries resulting from their pet.
- Owners agree to indemnify and hold harmless Eden Gardens from all liability and damage suffered as a result of their pet.

As someone bringing a pet into Nanaimo Travellers Lodge Society (NTLS)-Eden Gardens, I/we agree to the following;

1. Pay all repair costs resulting from pet damage caused by this pet
2. In the event that this/our pet causes a disturbance and cannot be adequately controlled; I/we will make arrangements to remove the pet from the workplace

Indemnification and Release In consideration of NTLS-Eden Gardens allowing this/our pet to visit Eden Gardens for the duration of my/our visit, I/we understand and voluntarily agree that I/we will be solely responsible for this/our pet and for any loss, damages, personal injuries, including death, sustained by this/our pet.

I/we Release and Agree to Hold Harmless, Indemnify and Defend the NTLS – Eden Gardens from any and all claims, lawsuits, actions, debts, bills, judgments, arising from or related to this pet's presence at Eden Gardens.

NOTE: (NTLS)- Eden Gardens reserves the right to refuse to accommodate and/or evict any animal that it determines, in its sole opinion, may create a hazard or disturb the other employees, residents or property.
